# **DHS Leadership Recruitment**

### **Novel Coronavirus**

- Sacramento County has had a total of 366,258 reported cases of COVID-19 and 3,657 deaths due to COVID-19 since February 2020.
- The current case rate is 4.5 per 100,000.
- Sacramento County has moved to CDC Community Level Low.
- The CA State of Emergency, local State of Emergency, and local Public Health Emergency are all scheduled to end on February 28, 2023.

#### Flu/RSV:

- Flu and RSV cases have continued to decrease from their peak in early December.
- Totals reported to SCPH this season to date:
  - o 42 flu ICU cases
  - o 34 flu deaths (one pediatric)
  - o 49 RSV ICU cases

# **CalAIM Planning**

- As of January 1, 2023, Enhanced Care Management (ECM) has been expanded to Long-Term Care (LTC) Populations of Focus, specifically for adults living in the community and at risk for LTC institutionalization and adult nursing facility residents transitioning to the community. # **Social Health Information Exchange**

 DHS is continuing its planning work for the SHIE, which is data infrastructure that aims to that link medical, behavioral health, social service and housing data from multiple sources countywide and strengthen care coordination between health and social service providers in Sacramento County.

- On 2/7/23, DHS is going to the Board for an RFP for an implementation consultant
- DHS is working on a SHIE vendor procurement and targeting late February for Board approval
- Adult Correctional Health (ACH) is working to develop an RFI/RFQ to identify Electronic Health Record system best suited for ACH, and can provide data and reporting to accommodate information requests and exchange

- Adult Outpatient Specialty Mental Health Services have now been incorporated into the Community Outreach Recovery Empowerment (CORE) program. The CORE program combines elements of Wellness and Recovery, TCORE, Guest House, and Regional Support Team programs, and adds new enhanced services (attachment).

- BHS continues to experience a workforce crisis, due to a shortage of workers in the field of behavioral health. Community members are encouraged to apply, as many BHS jobs are currently available:

    - BHS is committed to hiring a workforce that reflects the diversity of our community. As such, BHS is seeking a wide-ranging pool of applicants

from diverse backgrounds and different levels of clinical, professional and/or lived behavioral health experience, with high energy, compassion and enthusiasm for public service. - BHS continues to make progress on its new and innovative 24/7 Behavioral Health Crisis Call Center and Response Team, which will change the lives of individuals experiencing a crisis due mental illness or substance abuse. The Community Wellness Response Team (CWRT, formerly known as WCCCRP) will receive calls from community members experiencing a mental health crisis. Clinicians will dispatch Mental Health Response Teams which include Clinicians and Peers assigned to locations throughout the County. - BHS's Homeless Encampment and Response Team (HEART) continues its
  collaboration with DHA and Office of Homeless Initiatives (OHI) on the
  Encampment Team (ET) project, a proactive approach to reduce the number of
  people living unsheltered in the unincorporated County. HEART consists of
  Peers with lived experience and mental health Counselors whose work is
  overseen by a Licensed Clinician. Services are closely coordinated across county
  departments and lead with intensive and persistent outreach and engagement to
  ensure people are supported in accessing behavioral health services and
  transitioning to shelter and housing.

- BHS continues its collaboration with County and City-run homeless shelters by providing Mental Health Clinicians with designated office hours within the homeless shelters. These Clinicians provide engagement, outreach, screenings, and linkage to both our BHS mental health and substance use resources.
- Counterfeit prescription pills containing deadly fentanyl continue to circulate in the Sacramento County region. BHS continues to support awareness through its public service campaign to address fentanyl in the community. The intended outcome is to stop the dramatic increase in fentanyl poisoning deaths in Sacramento County.
- The Drug Medi-Cal Organized Delivery System (DMC-ODS) Member Handbook is now available in the County's seven threshold languages (Arabic, Chinese, Farsi, Hmong, Spanish, Russian, Vietnamese).
